Sub: **Protest against the anomalies in Transfer/Posting order in the grade of SDE(C) of WB Civil Co-ordination Zone.**

Ref: **Your letter No.3-1/2009-CEEZ/1359 dated 24.06.2010.**

Sir,

In continuation to the discussion had with your goodself & the representatives of the association dt. 28-06-2010 at your office and further the view of the association are being offered for record and reference for your acceptance are as follows:-

- A) The Kolkata based seniority list for the SDE/Civil, it has been confirmed that SI No. 1) R B Panja 2) T K Biswas 3) P K Sinha 4) Alope Roy 5) Shyamal Banerjee 6) Amal De 7) M K Dutta 8) U K Ghosh 9) P K Biswas. Out of the list two / three SDE have been dropped to bring the name of P . K . Biswas in the context of the Transfer order. Itself it is an anomaly.
- B) During discussion it was understood that the representation of Sri M K Dutta dt. 19-09.2009, requested to your kind authority for posting in the planning unit at Kolkata has not been considered as similar to the case of Alope Roy and the traditional conception of transfer, " the longest stayee would be transferred to the longest distance" have been violated in his case.
- C) Similarly, SI no 6) Amal De, does not come in the perview of transfer, if the Seniority list maintained strictly . The anomaly has started due to the exemption granted to Sri Alok Roy due to his personal ground . Now, if he is considered next time for transfer to Krishnanagar or Tarakeswar or any other place nearest to kolkata , definitely it would be a fit case of controversy or cause / evoke a lot of dispute in future.

- D) Meticulously, if the list followed very strictly on seniority basis name of M K Dutta & Amal De does not come in the perview of said transfer and posting order. As M K Dutta is 56 years old transferred at CSD-Darjeeling should be modified and considered his posting order should be nearest to kolkata, and for Amal de studying B.Tech after obtaining prior permission, he also should be posted nearer to Kolkata so that he can continue his study. Under any circumstances M K Dutta never should be posted at CSD-Darjeeling & Amal De at SDE-Plg-Siliguri.
- E) The posting order at CSD-Suri, CSD-Durgapur, SDE-Plg.-Malda, CSD-Darjeeling & CSD- Bankura should be reviewed as all the field postings are very sensitive in nature and justice of transfer should be allowed uniformly without appreciating any personal interest. Therefore, we request your goodself to review the entire order to extend justice to the aggrieved SDE/Civil and till then implementation of the order is requested to keep in abeyance for the final settlement of the anomalies as detailed above on the merit of the subject..

We are waiting for favourable solution & soliciting a meeting to be granted .
